However, this Council has observed following deficiencies/disputes during the inspection of your Institute.

1. B. Pharm course running within the same building along with D. Pharm, under WBUHS but not declared in Council portal
2. About 20% of the Pharmaceutics books and Pharmaceutical Chemistry books found to be of old syllabus, Less number of books found for new syllabus (ER-2020)
3. Herbal Garden not maintained properly, Number of plants found to be insufficient

You are advised to comply above mentioned deficiency(ies) and submit a compliance report to the Council within three (03) months.

All norms and standards of PCI and WBSCT&VE&SD shall have to be fulfilled by your Institution. Conduct of regular offline classes (at least 6 days in a week) is a mandatory requirement for affiliation of the course. No online class is allowed. In case of any deviation from the above conditions this provisional affiliation shall stand cancelled without any prejudice.

All admissions to the aforesaid courses shall be based on the admission system adopted by the Council in conformity with the guidelines issued/to be issued by the competent authority of the Council.
